The Society of Auctioneers & Appraisers (SA) Inc. was incorporated on the 3rd day of December 1981.

The Government of the time as part of their ongoing commitment to self-regulation had made a decision to repeal the Auctioneers & Appraisers Act of 1934-1961 where practitioners were required to be licensed.

The then Director General of the Department of Public & Consumer Affairs was concerned that there would not be a body representing Auctioneers and Appraisers in S.A. and had approached the Real Estate Institute of S.A. to form a suitable body to self regulate the Industry and to provide standards of Practice, Ethics and Codes of Conduct.

The Society came into being and the first meeting was held on 2nd April 1981



## Agents being caught by GST - Society Contract & Agency Agreement addresses all GST Issues

The Tax Office has indicated that it will investigate real estate transactions where GST should have been paid but was overlooked or not dealt with correctly. LawSoft has updated the Sales Agency Agreement and the Contract to require Agents to consider GST issues at the point of Agency and to confirm the GST status at time of contract signing.

Whilst most residential properties do not attract GST, newly created allotments, new dwellings and substantially renovated houses may have GST implications and in these instances, even if a Vendor is not registered for GST, the Vendor may be required to address GST implications. Most residential developers will opt to implement the margin scheme, however this must be agreed in writing between the Vendor and Purchaser prior to settlement. The AucDocs Contract has a tick box to confirm that the margin scheme is being used giving the parties to the transaction an opportunity to seek GST advice. Remember that Agents cannot give GST advice so it is imperative that the Vendor instructs you on GST issues.
