






Oren Klemich Trustee

General and livestock auctioneers are to submit 10 minutes of an auction – not including the conditions of sale.

There will be a QR code on the nomination form that will take you to the Facebook webpage. Judges will judge from the video and the public can vote by liking your performance.

Rising Stars will perform by auctioning a house in the conventional way where they will be given the property and all details several days prior to competing. Rising Star heats will be held in May 2017 – and nominations must be received by the end of April.






