# SOCIETY TRAINING JULY



The Society held a Documentation Update (Real Estate) on Tuesday the 12th July at the Arkaba to update members on recent legislative changes to ensure that each office complies with the new act and regulations.

Training can be a drag but Chris Gill is a vibrant presenter with a thorough knowledge of all issues as he works daily in the profession. We had a good response with the room full of members eager to participate in the discussion. If you haven't been to training in the last 2 years, it's time!

There will be things that you have forgotten and new legislative requirements like the ATO Disclosure for Sales Over \$2M and the usual issues like Pool & Spa compliance with issues that need clarification. Some of the issues that arose during the general discussion for example:

Q: Vendor spent \$50,000 on improvements after signing the Auction Agency agreement and wants to raise reserve accordingly.

Q: What are the advantages and risks with no price guide?

Q: How to serve a Form 7 and comply with Act?

Q: Would I ever need to use a Subsequent Agency or should I just execute a new 90 day agreement. What are the pitfalls and advantages?

Q: How to deal with improvements without Council consent in the Form 1, and how to draft the contract to suit?

There were plenty of discussions regarding the electronic Conveyancing and the implications for vendors and the need for the agents to identify the vendors especially now there is no duplicate certificate of title. The workshop was well attended, interactive with plenty of questions, with plain English answers with examples. It was a cold, wet, and windy day and just as we finished, the power went out and the venue was plunged into darkness—perfect timing!
